## HONORABLE BOARD OF POLICE COMMISSIONERS REGULAR MONTHLY MEETING MARCH 28, 2023 AT 7:00 PM 471 NORTH HIGH STREET EAST HAVEN, CT

**COMMISSIONERS PRESENT:** Chairman Dominic Balletto (presiding), Vice Chairman Joseph DiSilvestro, Commissioner Paul Carbo, Commissioner Dianne Romans, Commissioner Barbara Barbuito

Chairman Balletto called the meeting to order at 7:03 PM.

- 1. Pledge of Allegiance
- 2. Moment of Silence For the three 9-year-old students and three staff members killed at a Christian school in Nashville, Tennessee; and all those affected by this tragedy and gun violence.
- 3. Roll Call Clerk Maldonado; quorum obtained.
- 4. Announcement(s)
- 5. Consider and act upon the approval of the Monthly Meeting minutes of February 28, 2023

Vice Chairman DiSilvestro made a motion to accept and approve the Monthly Meeting minutes of February 28, 2023, as received; seconded by Commissioner Barbuito. All in favor. No one opposed or abstained. Motion carried unanimously.

6. Consider and act upon the approval of the Monthly Reports (March 2023)

Vice Chairman DiSilvestro made a motion to accept and approve the monthly reports as received; seconded by Commissioner Romans. All in favor. No one opposed or abstained. Motion carried unanimously.

- 7. Consider and act upon Committee Reports & Recommendations
- 8. Public Comment
  - a. Dan McCann (137 Mansfield Grove Road) Expressed concern for potential issues with cars parked in the Greenway Trail parking lot "after hours" as well as in the rear of D.C. Moore School near the basketball courts. Requests signage to discourage loitering and Commissioner

Carbo also suggested posting permissible hours for parking lot use [before sundown]. Chairman Balletto asked Chief Lennon for additional regular patrol of both locations.

- 9. Correspondence Received/Sent
  - a. The Office of State Senator Cicarella on behalf of constituent Linda Louison (via email, March 20, 2023) Ms. Louison requests for 1) a safe crossing zone, whether it be a traffic light or island on Foxon Road/Route 80 in East Haven at the bus stop in front of Planet Fitness; and 2) an assessment of an incomplete sidewalk as seniors, they find it very difficult to pull their carts along and at time have to step out into the very busy, dangerous roadway. Chairman Balletto deferred this matter to the Traffic & Public Safety Committee for review.

## 10. Department Updates (Chief Lennon)

- a. Personnel Matters/Injured Employees Two (2) patrol vacancy; expect a third in the coming weeks. Candidate interviews will be conducted later this evening.
- b. Overtime Tracking same as same pay period last fiscal year mostly due to backfilling for training hours, vacations, etc.

DC Tracy also mentioned two other reasons for the increase in overtime: 1) an increase in prisoner watches at hospitals – if someone is being held on a court-set bond and they need medical attention, we have to transport them to the hospital and guard that prisoner 24-hours per day which is beyond our normal patrol complement; and 2) recent changes in the "red flag" law which requires an officer apply for a risk protection order pursuant to state statute, and oftentimes it takes many hours to complete the paperwork, locate a prosecutor to review it, get a judge to sign off on it and then execute the order – this all takes a lot of time.

All in favor. No one opposed or abstained. Motion carried unanimously. Executive session commenced at 7:18 PM.

Candidate Matthew Longobardi went into executive session at 7:23 PM and exited at 7:34 PM.

Candidate Ana Morales went into executive session at 7:35 PM and exited at 7:41 PM.

Candidate Michael DiMaggio went into executive session at 7:45 PM and exited at 7:58 PM.

Vice Chairman DiSilvestro made a motion to conclude executive session; seconded by Commissioners Romans and Barbuito. Public session resumed at 8:12 PM.

Vice Chairman DiSilvestro made a motion to offer the position of Grade C Police Officer to Matthew Longobardi with a start date of April 17, 2023; seconded by Commissioner Romans. All in favor. No one opposed or abstained. Motion carried unanimously.

Chairman Balletto stated that at this time, the Commission has chosen to make only one appointment; however, the other candidates will remain on the list for consideration should there be future vacancies.

Chairman Balletto adjourned the meeting at 8:14 PM.
